## CONSTITUTION

1. This body shall be known as the Alachua Baptist Association.

2. It shall be composed of churches generally recognized as Missionary Baptist Churches.

3. Its session (Legislative, Administrative, Promotional and Fellowship) shall be by regularly elected representatives of the churches composing its membership, and other members of said churches who may be present and who may be accepted by the elected members, on the basis of two Messengers from each church, and one additional for each twenty-five members or major fractional part thereof, in excess of fifty.

4. The officers shall be a Moderator, Clerk, Treasurer and an Executive Committee, elected annually by vote of the messengers present.

5. The Executive Committee shall be the Moderator, Clerk, Treasurer and two additional members elected by the body in session, annually.

6. The Moderator shall preside over the sessions, keep order, take the vote on all questions properly presented and perform such other duties as are usual to such officers. The Clerk shall keep a correct record of the proceedings of the body in session, have the same printed and distributed to the churches according to the funds provided and as the body may direct. The Treasurer shall keep an accurate account of all monies received; pay it out upon the instruction of the body and make an itemized report of same to the Association at each annual session.

7. The Executive Committee shall have general supervision of the work fostered by the Association. It shall meet quarterly and plan for the promotion of various interests of the organized work, using its best efforts to stimulate the spirituality and activity of the churches, and shall make report of its work to the Association in its annual session.

8. The Association shall meet annually at such time and place as may be agreed upon by the body; or, when necessity arises, by the Executive Committee.

9. Churches may be admitted to membership in this Association by representatives bearing a petitionary letter

with statistical data; provided they are found to be orthodox by a committee appointed by the Moderator. Upon a favorable vote of the body, the Moderator shall extend the hand of fellowship on behalf of the Association.

10. The Association shall have the right and the power to withdraw fellowship from any church in its membership, upon grounds which it may deem justifiable.

11. Any church shall have the right to withdraw its membership from the Association upon due notice to the body.

12. Any church failing to report to the Association, neither sending representatives nor letters, twice in succession, shall be dropped from the roll of active members and put on a list of "inactive churches."

13. This Constitution may be altered or amended by a two-thirds vote of the body in session.

14. This Association accepts as a fundamental Baptist doctrine the inspiration of the Scriptures and offers to those only who hold the word of God to be the sole authority for our faith and practice.

*REPORT OF PROCEEDINGS*

FIRST MORNING, WEDNESDAY, OCTOBER 12, 1932

The Eighty-sixth Session of the Alachua Baptist Association convened with the Brooksville Church at Brooksville, Wednesday, Oct. 12th, 1932, at 9:30 a. m.

Center Hill, Fla., Oct. 9, 1932.

There are twelve Sunday Schools reporting in the Alachua Association, with an enrollment of 1,135, a gain of 78 over last year.

Total gifts amounting to \$1,021.37. These twelve schools have 143 teachers and for this year we had 46 baptisms from the Sunday Schools.

#### *REPORT ON STATE MISSIONS*

Florida Baptists gave last year to all missionary and benevolent purposes \$174,588.78. Of this amount, the Co-Operative Program received \$95,954.19. There was given in designated funds, which were sent to the various objects as directed by the donors, \$78,634.59.

The total amount available for State Mission work exclusively the past year was \$66,905.79. We gave to Foreign Missions \$28,182.97. To Home Missions \$9,255.10.

#### *REPORT ON THE WITNESS*

Why did Jesus organize His people into a church? Two reasons are apparent, viz.: For their own development in spiritual strength, efficiency and happiness. And, for the effective spread of the Gospel.

Undoubtedly it was of the Holy Spirit that, out of these purposes have come our Associations and Conventions. The members of a church may know its plans and progress by word of mouth; but, in the larger circles of co-operation we must have other means of information. God has provided this means to us in the Florida Baptist Witness. Surely it was God who sent to us Dr. E. D. Solomon to man this vehicle of Gospel information and inspiration.

The Witness fosters every interest that the churches do. It unifies our efforts in the dissemination of information concerning the planning in the churches, the associations, the conventions, boards, department leaders and executives.

It carries into our homes the thinking and work of our best men, women and churches. It is to our organized work what the newspapers and magazines are to the economic, political and social world. We read these because we are interested in the things about which they inform us and regard the information vital to our interest in them. A like interest in the things carried by the Witness should make us hunger for it and for all our denominational periodicals.

Never before has it been possible to secure our state paper for so low a price as now, in the budget plan promoted by Dr. Solomon. Every family may have it for one dollar a year by the budget plan, paying only 25 cents a quarter, just as we pay for our Sunday School literature. Only 2½ cents per quarter more than the cost of "The Challenge."

In the opinion of your committee this is the easiest and best method ever offered and one of the best investments a church can make. Let's do it.

#### *REPORT ON B. Y. P. U.'s*

Our churches and great denomination are looking to the young people in our B. Y. P. U. organizations for the future leaders in the Kingdom work. We are watching their progress with the deepest interest and earnest prayer, and note with pleasure that every phase of their work in the Southern Baptist Convention has shown an upward trend.

They have increased in the number of Unions and membership, in tithers and study course rewards, as well as in number of leaders absorbed by the other organizations of the churches. This has been accomplished under the handicap of the greatest financial depression we have seen in years. All over our Southland the B. Y. P. U. work among the young people is marching on to victory in a great way.

In our own beloved State the records show that we have a total of 149 General Organizations, 57 Adult Unions, 438 Senior Unions, 265 Intermediate Unions and 257 Junior Unions, making a total of 1,166 B. Y. P. U. Organizations. This shows an increase of 66, in the 9 months over that of 1931, as this report is only through August of 1932. There were 5,527 Study Course Awards given these Unions.

This work is carried on through the B. Y. P. U. promotional agencies under the direction of Dr. W. W. Willian, Supt. of the S. S. and B. Y. P. U. departments of the State; O. K. Radford, the field worker and the ever faithful Pastors of the local churches.

We find that during the first quarter of 1932, Florida had 75 Standard Organizations, but due to some vital changes in the Standard, this number fell to only 57 during the second quarter.

Miami Association had the greatest number of Unions, with 128 Unions and 2,238 membership; Tampa Bay, second, with 128 Unions and 2,024 members; Jacksonville Association third, with 118 Unions and 2,071 members; while Alachua Association had 18 Unions and 109 awards through August. Our own Association shows and increase of 7 Unions over that of 1931, or one more Union than the number of churches reported to the Association last year.

We have cause to be grateful to God for the work being done by the Young People of our Association. May God's hand lead them on.

## REPORT ON RELIEF AND ANNUITY

The Relief and Annuity Board was organized fourteen years ago.

During the year 1931 it paid benefits totaling \$211,017.59, thus aiding 1,514 ministers, missionaries, widows and orphans, and 211 received annuities.

The new form of Annuity Contract, styled the Service Annuity, inaugurated by the Board January 27th of this year, but made retroactive to January 1st, 1932, is now being issued.

The total assets of the Board are approximately \$4,000,000.00. The business affairs of the Board are carefully handled by committees on which are able business and professional men of Dallas, Texas.

Its funds are invested in sound securities.

## REPORT ON TEMPERANCE

Our subject today is Temperance or more properly Prohibition.

This is one of the most important subjects of our day. It is important because of the dangerous and evil effect that the abolishment of prohibition would have on our people—mentally, morally, financially and last but not greatest, Spiritually.

The wets are a bunch of people who are mentally very shrewd and financially they are very strong.

The church has always opposed the liquor traffic, illicit or legalized. For many years the Spiritually "minded" of our nation put forth every effort to devise some plan whereby this great evil could be abolished or its powerful influence curtailed at least. We have outlawed the manufacture and sale of intoxicating beverages.

The wets, realizing their defeat, are today in many instances coming just as Jesus tells us in Matt. 7:15, "In sheeps clothing but inwardly they are ravening wolves."

We find right now at our doors (after twelve years of National Prohibition) the liquor interest boasting of their contempt for the fundamental law of our land and trying to bluff our American people by threats of civil war if they are not permitted to have their way.

The wets are working towards three lines: (1st) to break down and discredit the character of every preacher or any one else that opposes them; (2nd) They are trying to convince the people that law enforcement is an expensive and impossible undertaking; (3rd) They are trying to bring about a political situation that will confuse and divide the minds of the voters to the extent that they will be put in authority at the head of our government.

### HOME MISSION REPORT

Southern Baptist have been working at Home Missions in an organized, united effort now for more than eighty-five year, and six years ago, before the depression struck our nation, the workers of this Board delivered more than one hundred thousand messages, conducted nearly twenty thousand prayer-meetings, baptized more than twenty thousand candidates, distributed more than ten thousand Bibles and Testaments, and circulated more than one million five hundred thousand tracts.

Our Home Board's work in Florida five years ago included five state evangelist, under whose preaching fifteen hundred souls were reached; and also the Seaman's Institute in Jacksonville, as well as work among the foreigners in Tampa; but alas, the depression, and a wave of world-iness among our members, has curtailed much of our work in Florida and elsewhere.

Through and from our work in Cuba, among the Indians, the negroes, the foreigners and the mountain people, eternity alone will reveal what mighty things have been accomplished by our united efforts on behalf of Home Missions.

May the dear Lord help us to be four-square children of our glorious coming King in our praying, our thinking and our giving, ever observing the scriptural order, "In Jerusalem, in all Judea, and Samaria (Home Missions,") as well as "unto the uttermost part of the earth."

### REPORT ON FOREIGN MISSIONS

There comes to us great expansion of heart with renewed determination to press forward when we hear of the marvelous triumphs of our work in other lands. Our missions are prospering wonderfully.

In 1906 we had 241 churches. By 1931 these had grown to 2,681 churches; 1,868 of these are self-supporting.

In 25 years the membership grew from 12,894 to 169,311. We baptized more people last year on the foreign fields than we had members 25 years ago. The largest number of baptisms ever reported on our foreign fields came to us in 1931 when the total reached 16,586.

The contributions of these churches last year reached the amount of \$145,000.00 more than Southern Baptists gave for the support of the Foreign Mission Board in 1906.

An outstanding assurance about our work abroad during the last two years, has been the wonderful way in which it has stood the strain caused by our failure to support it properly during that period. It encourages us to take up with more hopeful zeal the support of the work in a larger way in the future.

We have the secret that will fill all the world with joy, and cause it to ring with the praise of God. Shall we halt? Shall we turn our back on the world? Shall we call home the messengers we have sent out, or shall we maintain and re-enforce them?

### REPORT ON CHRISTIAN EDUCATION

Our Nation is making rapid strides in educational fields. Larger buildings, better equipment and more efficient teachers are demanded as we advance along economic, social and industrial lines.

Your committee feels that as we advance in learning in secular matters there are indications that greater emphasis is being placed upon the training of the mind and body than upon the development of the soul.

There seems to be a dirth of religious training beginning in the home and extending through our educational systems from the primary grades through our largest universities.

We, your committee, recommend more suitable and wholesome literature in the home, such as our denominational periodicals and Bible studies to replace some of the degrading literature of the age to offset its demoralizing influence.

We respectfully urge all parents to see to it that their children get the uplifting influence of our Sunday Schools, B. Y. P. U.'s, and regular preaching services of the church.

It is of great importance to make careful and prayerful selection of the college which our children attend.

We recommend our Christian colleges in preference to State Institutions.
