MINUTES.

Mt. Gilead, Baptist Church. Suwannee County, Fla. October 17 1901

The Suwannee Baptist Association met this day in its thirtieth annual session in the above named church, where the Association had adjourned, the previous year, to meet. At 11 o'clock a. m. it was called to order by Brother W. S. Hodge, the Moderator of the previous Association.

Devotional exercises were conducted by Brother W. S. Hodge, which consisted in the reading of a scripture lesson and singing, with prayer by Elder J. S. Parker. Upon motion, Rev. B. M. Bean was selected to preach the introductory sermon: the Association took a recess until 2 o'clock p. m.

The introductory sermon was preached from the 7th verse and 9th chapter of 2nd Corinthians: the words, "God loveth a cheerful giver"

FIRST DAY AFTERNOON SESSION

At 2 p. m. the Association reassembled. The Moderator read the 5th chapter of 2nd Corinthians. Prayer by Rev. J. C. Porter. The Moderator appointed Brothers J. R. Newlan and N. L. Chauncey reading clerks.

After devotional exercises, the Association adjourned until 9 a. m. fomorrow.

The Association was called to order, after pleasant singing exercises, by the Moderator reading the 2nd chapter II Peter, and prayer by Rev. B. D. Harrell.

Your committee on Ministerial Education have had the same under advisement, and beg leave to report, that they are glad to know that the interest in Ministerial Education in the Baptist de-

nomination, grows stronger every year. As an encouragement to our churches, we would suggest the wisdom of adopting the language of Solomon: Prov. 4: 7-8: "Wisdom is the principal thing; therefore get wisdom; and with all thy getting; get understanding. Exalt her, and she shall promote thee: she shall bring thee to honor, when thou dost embrace her." The weal or woe of the Baptist denomination, very largely depends upon the wisdom of our ministers; therefore it is necessary to have wisdom to contrive, and the power of knowledge, to adorn the profession of our faith. As an evidence of the increasing desire of our denomination for a more thorough training of our ministers, we can with thankful hearts report that there are now in our own Stetson University, ten or twelve young men taking a theolog ical course for the ministry; and in the Seminary, at Louisville, there are one hundred and seventy-five. With these facts before us. we have great cause to glorify God, and press the battle harder for a more thorough training of our ministry. We claim to be the light of the world, and if we are, we should never be satisfied. until we can lead the vanguard of the world with well trained leaders. Lay hands suddenly, on no man. If we ever expect to take the world for Christ, it must be done through wise and welltrained leaders. Perilous times are coming. We live in the midst of a gainsaying world: factions are springing up on every hand. and how shall we meet them, without an educated ministry?

By motion of Rev. B. M. Bean, the clerk was instructed to include the report of the Ladies Missionary Society, in the minutes of the Association.

The following resolution was presented by Rev. B. M. Bean. Resolved—That a member be appointed in each church to distribute mission literature and collect money for foreign missions, and that the pastor of each church appoint such member. The resolution was adopted.

The following report was read by the clerk, from the committee on

TEMPERANCE.

We, your committee on Temperance, beg leave to make the following as our report. First, we believe that intoxicating liquor is one of the greatest evils of the land. We gather from practical lessons, the following, even from the pen of Ingersoll, the great light of infidelity, and opposer of Christianity. He says.

It breaks the fathers heart, bereaves the doting mother, blights parental hope; and "brings mourning age to the grave." It produces weakness, "not strength," sickness, "not health," death, "not life." It makes wives "widows," children "orphans," fathers "fiends," and all of them paupers and beggars. It covers the land with idleness, "misery and crune." It fills jails, supplies almshouses and demands asylums. It fosters quarrels, and "cherishes riot." It crowds penitentiaries, and furnishes victims for the scalfold.

Oh! if Christians, those who are born of God, would do, as they are "commanded to do," "touch not, taste not, handle not," the "unclean thing," what an influence it would have upon those under the fostering care of a religious faith.

The great burden of taxation to run the courts of our country would be lightened, and the money, thus expended, could be used to send the Gospel of a bleeding Savior, to a dying people in foreign lands. Our sons and daughters, in place of bringing gray hairs down in sorrow to the grave, would be shining lights, and better prepared to enter into that test that remains for the people of God. "Brethren," those who profess to be "lovers of the Lord," there is very little good accomplished to meet once a year and write up reports, pay a clerk ten dollars, a printer twenty dollars, and get our work in minute form, carry them home and lay them away, merely for reference, for the next Association.

For "Heavens sake," let us pray the Lord to help us get aroused from our lethargy, and put our works into action, and we solicit the churches of this Association to use stricter discipline in regard to intemperance.

SABBATH SCHOOLS

To the Members of the Suwannee Baptist Association: We your committee on Sabbath Schools, beg leave to report as follows: We find that there are but few Sabbath Schools in the churches of our Association, many churches not having had one for years. We know that it is very difficult to keep up a Sabbath School in a country church, owing to the distance from the home to the Lord's 'house; but, brethren, we have sons and daughters, growing up into manhood and womanhood, who in a few short years will take our places, in church, in government, and in the social affairs of life, and the duty, and the responsibilities are upon us to teach them the Scriptures, which are able to make them wise unto Salvation through faith which is in "Christ Jesus." Even as Timothy, when a child, was taught by his grandmother. Lois, and mother. Eunice. The teaching of the Scripture to our children, not only leads them into the way, the truth and life eternal as it is Christ Jesus, our Lord, but it also trains them for good, active church work which so shortly must be theirs to do. It also fits them for the best citizenship, thus qualifying them for all the religious and social duties of life.

It is the imperative duty devolvent upon every Christian parent to teach their children the Holy Scriptures; and to such a duty God will hold all parents to a strict accountability; therefore, we your committee, do recommend and urge that, the ministers and laymen of our Association do bestir themselves as never before, and to see to it that every church within our bounds shall establish and maintain a Sabbath School; so that when we meet again next year, there shall not be a single church without a school.

It will take prayerful, earnest and persistent efforts to do this, but rest assured "brethren." that our Heavenly Father will crown such labors with success, and then we shall have prosperity of soul, of body and of mind; and then too, error, which is being taught by others within our bounds, shall be crushed and truth rise triumphant and be manifested and held sacred by our posterity in years to come: so let every church in our Association, report that they have a Sabbath school when we meet again next year.

Your committee, to whom was referred the subject on Ministerial Support, have had the same under consideration, and beg leave to report, that the subject is one of vital interst to the cause of Christ, and the existence of the churches. It is a source of deep regret to your committee, to learn from the reading of the church letters, that so little is being done to support their pastors. The "Lord hath ordained that," they that "preach the Gospel, shall live of the Gospel." And again, "the laborer is worthy of his hire."

From investigation, we find that there are churches with memberships varying from twenty-five up, that give from fifteen to twenty-five dollars for their pastor's support. It is not to be wondered at that churches become pastorless. We would suggest as a remedy for these exils that pastors educate the churches more thoroughly on this line of Christian duty. Without a great change from this course of conduct pastors will be driven from the pulpit to seek support from the secular pursuits of life.

ON MISSIONS

In Romans 1:4 Paul said "I am debtor both to the Greeks and to the barbarians; both to the wise and the unwise." The apostle meant by this, that the receiving of the knowledge of Salvation through the Lord Jesus, brought him under obligation to give that knowledge to everyone who was without it. And so it is time that, if we have received a saving knowledge of Jesus, we are in duty bound to give it to everyone who is without it. This then makes it our duty to give the gospel not only to Florida, but also to the benighted heathen nations of the world. There is much to be thankful for, and to encourage in the great work being done among the heathen as well as in our own land. But of the one billion and four hundred millions of earth's inhabitants, only about one-tenth are processed followers of the Lord. These figures show at least that by far the largest part of the world's inhabitants are yet without knowledge of Jesus. It follows then, according to the text quoted in the beginning of this report, that a heavy debt rests on the Lord's people. We owe the Gospel to all who are without it. We are debtors to all who have not the knowledge of the saving power of the Gospel. Let us do all in our power to pay the debt we owe to the benighted world

Yes, such deeds, verily, we believe are sweet smelling alabaster boxes in the presence of the Lord.

Let us rejoice in the increasing number of noble, devoted. Godly women who are actually giving their lives to the cause of missions. The picture of these God-given young men and women on the pages of our journal, should be incentives to our best efforts in co-operating with them in our sympathy, prayers and means.

We especially speak of Miss Mary Taylor, our missionary in Cuba. The women of the state have assumed the work of supporting her. How we wish every woman of the state knew her personally. Every one who meets her wants to be better, and do better. Dear sisters, we earnestly beg of you that each may lay hold of the rope, while their faithful diver is gathering where there are so many pearls. May the Lord impress every one to go home and shell peas, or do something to help in her support, that you may be sharers in the great harvest he is going to give us from Miss Mary Taylor being in Cuba.

The true spirit that will move every one to work, is found in the following extract from Sister Mill's report of the Tiger Lake society, to the woman's associational meeting. We have been brought by Divine Grace to a study of the Bible and have been urged by our elder sisters to organize ourselves for work in the cause of our Master, and by doing so, we have been brought to more fully realize the great responsibility that rests upon us as professors of the missionary cause.

Sunday, Rev. R. F. Rodgers preached an able doctrinal sermon to a large and attentive audience from 1st verse 4th chapter of Malachi, after which a collection of \$7.66 was taken up for Mrs. Laura Lawrence, an invalid.

CONSTITUTION.

Section 1. This Association shall be known as the Suwannee Baptist Association.

Section 2. This Association shall be composed of messengers elected by the several churches connected with the Association, each church being entitled to two messengers, and one additional messenger for every twenty-five membrs, or fractional part there-of, over fifty, and such members shall be received by the Association.

Section 3. This Association shall, at their annual meeting, elect from their members, by ballot, a Moderator, Clerk and Treasurer, who shall serve for one year.

Section 4. The object of this Association shall be: First, to promote unity and brotherly love among the churches. Second. to promote Gospel discipline. Third, to encourage the universal spread of the Gospel and practical religion throughout our bounds and elsewhere.

Section 5. A Missionary Committee shall be appointed by the Moderator at each annual meeting of the body, subject to the approval of the Association, whose duty it shall be to diligently inquire into the destitution within our bounds, make contracts with ministers of this Association, or other Associations in correspondence with this, for ministerial labors to supply these destitutions, and report the result of their labors for the approval of the Association.

Section 6. This Association shall invite correspondence and visiting brethren to seats when in session, who shall be entitled to the privilege of aiding the Association with their counsels; and this Association may also withdraw from any church that may be in disorder, when the same cannot be restored.

Section 7. The annual meeting of this Association shall begin on Thursday before the third Sunday in October, and by appointment there shall be an Introductory sermon preached the first day, and on the Sabbath a collection taken up for missionary purposes.

Section 8. This Association shall not lord it over God's heritage, nor infringe upon any of the internal rights of the churches, but shall only act as an advisory body.

Section 9. This constitution may be amended only by a twothirds vote of the messengers present, provided the amendment be reduced to writing.

ARTICLES OF FAITH

- We believe in one only true and living God, the Father.
 Son and Holy Ghost, and that these three are one.
- We believe that the Old and New Testament Scriptures are Word of God, and the only rules of faith and practice.
- 3. We believe in election, according to the foreknowledge of God, through sanctification of the spirit and belief of the truth.
- 4. We believe that the grace of God that bringeth salvation hath appeared unto all men, and that nothing prevents the salvation of the vilest sinner on earth but his own voluntary rejection of that grace.
- 5. We believe in the total depravity of the human heart, and that the natural state of man is such that he cannot prepare himself for divine favor without the assisting grace of God, enabling him to act according to the good pleasure of His divine will.
- We believe in justification by faith, which gives peace with God. through our Lord Jesus Christ.
 - 7. We believe that the Gospel of Christ is a means of divine

appointment, to bring sinners to repentance and faith in Jesus Christ, and therefore should be preached to all.

8. We believe that all those who are regenerated by the Spirit of God are made heirs of God and joint heirs with our Lord and Savior Jesus Christ; and that they are kept by the power of God through faith unto eternal salvation, and that not one of them will be lost.

9. We believe that baptism is the immersion of the whole body in water; that the only proper subjects are described in the preceding articles, and the only proper administrators are those who have been regularly ordained by a church of Christ by the imposition of hands of a presbytery.

10. We believe that the Lord's Supper was instituted by our Lord Jesus Christ, to be commemorated by His followers, and that none but baptized believers have a spiritual right to partake thereof.

11. We believe that the washing of feet, according to the example recorded in the thirteenth chapter of John's Gospel, is a duty enjoined by the Lord Jesus Christ upon His followers, and should be observed immediately after the Lord's Supper, but in no case shall this article be so constructed as to make it a test of fellowship.

12. We believe in a general resurrection of the righteous and the wicked, and that the wicked shall go away into everlasting punishment, and the righteous into life eternal.

13. We believe that infants and idiots are saved through the merits of our Lord Jesus Christ.

RULES OF DECORUM

Article 1. At the first meeting of each annual session of the Association, the Moderator of the previous session shall call the messengers to order, and, after singing and prayer, he shall declare the Association ready for business; the first item being the election of a Moderator and Clerk, after messengers have enrolled their names. In case of absence of the Moderator, the messengers present shall elect a Moderator pro tem, who shall proceed as aforesaid.

Article 2. Each meeting of the Association shall be opened and closed with singing and prayer.

Article 3. The Moderator shall preserve order and decide all

questions in debate, subject to an appeal to the body, and when speaking on any subject, shall call some member to the chair, and in case of a tie may give the casting vote.

Article 4. All committees shall be appointed by the Modera tor, subject to a vote of the body.

Article 5. The clerk shall keep a careful record of the proceedings of each meeting, and, in the absence of the Moderator, shall call the Association to order and preside until a Moderator pro tem. is elected.

Article 6. No business shall be transacted without a quorum, who shall consist of a majority of the registered members.

Article, 7: All members wishing to speak shall arise and respectfully address the Moderator, confining themseives strictly to the subject, and no unkind allusions shall be made while speaking.

Article 8. No motion shall be debated until seconded, nor voted upon until stated by the Moderator or read by the clerk.

Article 9. When a question is under debate no motion shall be received, except to adjourn, lay on the table, to amend, indefinitely postpone, refer to a committee, or otherwise call for the previous question.

Article 10. Any member voting in the majority may move a reconsideration at any time during the session,

Article 11. The rules of decorum may be amended at any annual session of the Association by a majority vote of the members present.
