#### CONSTITUTION.

SECTION 1. This Association shall be known as the Suwannee Baptist Association.

- SEC. 2. This Association shall be composed of messengers elected by the several Churches connected with the Association, each Church being entitled to two messengers, and one additional messenger for every twenty-five members, or fractional part thereof, over fifty, and such members shall be received by the Association.
- SEC. 3. This Association shall, at their annual meeting, elect from their members, by ballot, a Moderator, Clerk and Treasurer, who shall serve for one year.
- SEC. 4. The object of this Association shall be: First, to promote unity and brotherly love among the Churches. Second, to promote Gospel discipline. Third, to encourage the universal spread of the Gospel and practical religion throughout our bounds and elsewhere.
- SEC. 5. A Missionary Committee shall be appointed by the Moderator at each annual meeting of the body, subject to the approval of the Association, whose duty it shall be to diligently inquire into the destitution within our bounds, make contracts with ministers of this Association, or other associations in correspondence with this, for ministerial labors to supply these destitutions, and report the result of their labors for the approval of the Association.
- SEC. 6. This Association shall invite correspondents and visiting brethren to seats when in session, who shall be entitled to the privilege of aiding the Association with their counsels; and this Association may also withdraw from any Church that may be in disorder, when the same cannot be restored.
  - SEC. 7. The annual meeting of this Association shall

begin on Thursday before the third Sunday in October, and by appointment there shall be an Introductory Sermon preached the first day, and on the Sabbath a collection taken up for missionary purposes.

- SEC. 8. This Association shall not lord it over God's heritage, nor infringe upon any of the internal rights of the Churches, but shall only act as an advisory body.
- SEC. 9. This Constitution may be amended only by a two-thirds vote of the messengers present, provided the amendment be reduced to writing.

#### Articles of Faith.

- 1. We believe in one only true and living God, the Father, Son and Holy Ghost, and that these three are one.
- 2. We believe that the Old and New Testament Scriptures are Word of God, and the only rules of faith and practice.
- 3. We believe in election, according to the foreknowledge of God, through sanctification of the spirit and belief of the truth.
- 4. We believe that the grace of God that bringeth salvation hath appeared unto all men, and that nothing prevents the salvation of the vilest sinner on earth but his own voluntary rejection of that grace.
- 5. We believe in the total depravity of the human heart, and that the natural state of man is such that he cannot prepare himself for divine favor without the assisting grace of God, enabling him to act according to the good pleasure of His divine will.
- 6. We believe in justification by faith, which gives peace with God, through our Lord Jesus Christ.
- 7. We believe that the Gospel of Christ is a means of divine appointment, to bring sinners to repentance and faith in Jesus Christ, and therefore should be preached to all.

- 8. We believe that all those who are regenerated by the Spirit of God are made heirs of God and joint heirs with our Lord and Savior Jesus Christ; and that they are kept by the power of God through faith unto eternal salvation, and that not one of them will be lost.
- 9. We believe that baptism is the immersion of the whole body in water; that the only proper subjects are described in the preceding article, and the only proper administrators are those who have been regularly ordained by a Church of Christ by the imposition of hands of a presbytery.
- 10. We believe that the Lord's Supper was instituted by our Lord Jesus Christ, to be commemorated by his followers, and that none but baptized believers have a spiritual right to partake thereof.
- 11. We believe that the washing of feet, according to the example recorded in the thirteenth chapter of John's Gospel, is a duty enjoined by the Lord Jesus upon his followers, and should be observed immediately after the Lord's Supper, but in no case shall this article be so construed as to make it a test of fellowship.
- 12. We believe in a general resurrection of the righteous and the wicked, and that the wicked shall go away into everlasting punishment, and the righteous into life eternal.
- 13. We believe that infants and idiots are saved through the merits of our Lord Jesus Christ.

#### Rules of Decorum.

ARTICLE 1. At the first meeting of each annual session of the Association, the Moderator of the previous session shall call the messengers to order, and, after singing and prayer, he shall declare the Association ready for business; the first item being the election of a Moderator and Clerk, after messengers have enrolled their names. In case of

absence of the Moderator, the messengers present shall elect a Moderator pro tem., who shall proceed as aforesaid.

- ART, 2. Each meeting of the Association shall be opened and closed with singing and prayer.
- ART. 3. The Moderator shall preserve order and decide all questions in debate, subject to an appeal to the body, and when speaking on any subject, shall call some member to the chair, and in case of a tie may give the casting vote.
- ART. 4. All committees shall be appointed by the Moderator, subject to a vote of the body.
- ART. 5. The Clerk shall keep a careful record of the proceedings of each meeting, and, in the absence of the Moderator, shall call the Association to order and preside until a Moderator pro tem. is elected.
- ART. 6. No business shall be transacted without a quorum, which shall consist of a majority of the registered members.
- ART. 7. All members wishing to speak shall arise and respectfully address the Moderator, confining themselves strictly to the subject, and no unkind allusions shall be made while speaking.
- ART. 8. No motion shall be debated until seconded, nor voted upon until stated by the Moderator or read by the Clerk.
- ART. 9. When a question is under debate, no motion shall be received, except to adjourn, lay on the table, to amend, indefinitely postpone, refer to a committee, or otherwise, call for the previous question.
- ART. 10. Any member voting in the majority may move a reconsideration at any time during the session.
- ART. 11. The rules of decorum may be amended at any annual session of the Association by a majority vote of the members present.

#### MINUTES.

#### Thursday Morning.

UNION BAPTIST CHURCH, SUWANNEE COUNTY, FLA., October 16, 1902.

The Suwannee Baptist Association met this day in its thirty-first session, with the above named Church, at 10 o'clock a. m. The Introductory Sermon was preached by Elder L. D. Giger, from Luke 5:16, after which the Association took recess until 2 p. m. At 2 p. m. the Association reassembled; the former Moderator, Clerk and Treasurer being absent, Elder J. F. Tatum was chosen Moderator pro tem. and W. W. Leggett, Clerk. Messengers then responded to the call from the following Churches and their names were enrolled:

The body proceeded to a permanent organization by electing Elder J. F. Tatum, Moderator; W. W. Leggett, Clerk; and T. C. Williams, Treasurer.

A call was made for petitionary letters. No response.

The call for correspondents was accepted by Elders J. C.

Porter and L. D. Giger.

Elder L. D. Giger made an able address upon the work of the State Board, and the following pledges were made to liquidate the debt that is hanging over the State Board: Rev. A. Bond, \$2.00; Rev. T. The Committee on Preaching reported Elder W. B. High to preach Friday at 11 o'clock a. m. and Elder R. E. Parnell alternate.

On motion the Association adjourned until 9 o'clock Friday morning.

#### Friday Morning.

The Association met, pursuant to adjournment, at 9 o'clock a.m. Friday, and was called to order by the Moderator. Reading of 19th Psalm, singing hymn "Nearer, My God, to Thee," and prayer by Elder J. F. Tatum.

The minutes of yesterday's meeting read and approved. A call was made for correspondents, and Elder W. B. High, from Hamilton, and Elder R. E. Parnell, from Beulah, accepted the call.

The following report was read by the Chairman: Your Committee on Missions find, in Romans 1:14, Paul said, "I am debtor to the Greeks and to the barbarians, both to the wise and unwise." The Apostle meant by this that the receiving of the knowledge of salvation through the Lord Jesus brought him under obligations to give that knowledge to every one who was without it. In the fifth verse Paul said, "I am ready to preach the gospel to you that are at Rome also." If we have received a saving knowledge of Jesus, we are in duty bound to give it to every one who is without it. The Apostle said in Romans 1:16, "For I am not ashamed of the gospel of Christ, for it is the power of God unto salvation to every one that believeth: to the Jew first, and also to the gentile"-which makes it our duty to give the gospel not only to the people here, but to the farthest heathen nations of the world. There is much to be thankful for, and to encourage others this great work is being done in China and Japan, Italy and India, as well as in our own land. But there is only about one-tenth of the earth's inhabitants professed followers of Christ. And further, there are only a few of the professors of religion who do anything to make known the Gospel to others. The largest part of the world's inhabitants are yet without the Gospel of Christ. It follows then, according to the text laid down in the beginning of this report, that a large debt rests on the Lord's people. We owe the Gospel to all who are without it. We are debtor to all who have not the Gospel of Christ. Let us do all in our power to pay the debt we owe to the heathen world. Respectfully submitted.

At 11 o'clock Elder W. B. High preached an able sermon from the 9th chapter and first clause of 4th verse of the Gospel of John.

#### Friday Afternoon.

At 2 o'clock the Association met pursuant to adjournment. The 2nd chapter of I Timothy was read and a hymn sung. Prayer was offered by Rev. J. S. Parker.

The call was renewed for messengers and the following Churches responded: Blue Springs, J. M. Adams and J. H. Grant; Oak Grove, Rev. J. S. Hurst; Clayland, R. Greene; Tigar Lake, G. H. Dorman and Sister Meta Horne; Mt. Pisgah, E. A. Carver, J. W. Knight, W. M. Harrell and W. J. Williams; Friendship, Warren Tucker; Live Oak, W. B. Collins.

The following report from the Committee on Temperance was read: We believe that intoxicating liquor is one of the greatest evils in the land. We gather from practical lessons the following, even from the pen of Ingersoll, the great light of infidelity and opposer of Christianity. He says intemperance cuts down youth in its vigor, manhood in its strength and age in its weakness. It breaks the father's heart, bereaves the doting mother, blights parental hope and brings mourning age to the grave. It produces weakness, not strength; sickness, not health; death, not life. It makes wives "widows," children "orphans," fathers "fiends," and all of them paupers and beggars. It covers the land with idleness, misery and crime. It fills the jails, supplies almshouses, and demands asylums. I fosters quar-

rels and cherishes riot. It crowds penitentiaries and furnishes victims for the scaffold.

Oh, if Christians, those who are born of God, would do as they are commanded to do, "touch not, taste not, handle not," the unclean thing, what influence it would have upon those under the fostering care of a religious faith.

The burden of taxation to run the courts of our country would be lightened, and the money thus expended could be used to send the Gospel of a bleeding Saviour to a dying people in foreign lands. Our sons and daughters, in place of bringing gray hairs down in sorrow, would be shining lights, and better prepared to enter into that rest that remains for the people of God. Brethren, those who profess to be lovers of the Lord, there is very little good to be accomplished to meet once a year, write up reports, pay a clerk ten dollars, a printer twenty dollars to get our work in minute form, carry them home and lay them away merely for reference for the next Association. For heaven sake let us pray the Lord to help us get aroused from our lethargy and put our work into action and solicit Churches of this Association to use strict discipline in regard to temperance.

Resolved, That it is the sense of your committee that any member of a Church in this Association, who is known to drink intoxicants as a beverage, shall be dealt with by his Church, and if he does not abstain from it we recommend that he be excluded from the fellowship of the Church.

We further recommend that all our members vote as they pray, for the complete overthrow of the liquor power in our county. Respectfully submitted,

The Association met pursuant to adjournment at 9 o'clock and was called to order by the Moderator.

Reading, the 5th Chapter of First John, and singing hymn "Come Let Us Join Our Cheerful Song." Prayer by the Moderator.

The minutes of yesterday were read and approved.

The call for messengers was resumed, and Bro. J. P. Alderman responded from Rosemary.

Your Committee on Ministerial Education beg leave to report:

We have had the same under consideration and are glad

that the interest in the ministerial education of the Baptist denomination is growing stronger every year. We find five students in the Seminaries at Louisville, Ky., two in Stetson University at DeLand, Fla., two at Carson-Newman College at Fernandina, Fla. and one in Chicago University. Therefore it is well said to have wisdom to continue and the power of knowledge to adorn the profession of our faith, as an evidence of the increasing desire of our denomination for a more thorough training of our ministry.

We claim to be the light of the world and if we should never be satisfied until we can lead the vanguard of the world with well trained soldiers, if we ever expect to take the world for Christ, it must be done through wise and well trained leaders. First. Christian parents, can we not use any persuasive language to cause you to take a deeper interest in your children? Go to Sabbath School with them, help to train them in the way that they should go. It is perfectly natural, and we know that you love your children, and why, oh why, not look for the welfare of their immortal souls? For the love or our children and for heaven sake let us go to Sabbath School, praying that the Lord will help our children to understand the ways of truth and righteousness and be saved.

#### Woman's Work.

Your Committee on Woman's Work beg leave to report as follows:

We learn from the reading of the Sacred Scriptures that God in his wisdom recognizes the fitness of women to aid in the great cause of reclaiming a lost and ruined world for Christ. Years ago, from a peculiar sense of modesty, women refrained in many instances from diving deep into the heathen lands to reclaim the lost. The nineteenth and twentieth centuries have witnessed a grand and glorious change—Nineyah must be warned.

A striking instance of this noble feminine consecration can be referred to in the case of Miss Helen M. Stone. While we cannot all be examples of Miss Stone, we can and do claim, to be without fear of successful contradiction, missionaries in spirit and in truth.

Our success as mite gatherers challenges the admiration of all missionary workers everywhere.

Show us a Church where there is a live Woman's Missionary Society, and we will show you a pastor who is paid for his services. Sisters who make sacrifices for this noble work become more consecrated each year. We have only to refer to our statistics to show that God's blessings rest on our efforts.

Our home Secretary makes profound acknowledgment for the noble work of the Woman's Missionary Union, and the true succor of the interest committed to the Home Mission Board. The cash contribution of the Woman's Missionary Union last year to the Home Board was \$195.10.

Our Foreign Mission Work shows we had 1439 baptisms in foreign lands, and our contributions went up to \$173,-439,00, of which the sisters raised \$34,787.39. Our largest annual contribution heretofore was only \$156,083.33. Now, dear Brethren and Sisters, have we not much to praise God for? We know that we can do nothing without the help of

the dear Savjour—we are only instruments in his hands. But let us be live instruments; let us be up and doing.

There is no time to waste while hungry souls are perishing for the bread of life. We can only deplore the circumstances which surround the motives of churches claiming to be missionaries, who do nothing for the cause of missions.

#### On Association Missions.

To the Members Comprising the Suwannee Baptist Association:

DEAR BRETHREN:-We, as your Committee on Missions, have diligently inquired into the destitutions within our bounds, and through the assistance of Bro. L. D. Geiger and B. M. Bean we succeeded in getting Bro. J. D. Mackie, of Charleston, S. C., to come to Live Oak to take charge of our mission field. Bro. Mackie did not remain with us long before returning to Charleston. It seems as the work did not suit Bro. Mackie and we released him. We can see a great need of having a missionary within our bounds to preach missionary doctrine and stir up the Churches in the cause of missions, as well as giving the Gospel to sinners. We can see that all are badly needed, though without a spirit of giving to the Lord can be aroused among our brethren and churches, we are helpless in missionary work.
