

Constitution

Article 1. This organization shall be known as the Suwannee Missionary Baptist Association.

Article. 2. The specific objects of this Association shall be:-

- 1. To unite the influence and pious intelligence of the Baptists within its bounds and thereby facilitate their union and co-operation.
- 2. To form and encourage plans for the revival of experimental and practical religion and the spread of the gospel within the bounds of this Association, and elsewhere.
- 3. To aid weak churches in our bounds.
- 4. To encourage and aid the education of our pious young men who may be called by the Spirit and approved by their churches for the work of the gospel ministry.
- 5. To promote pious and useful education among all Baptists.
- 6. To care for the needy orphans among us.
- 7. To aid in any work whose object is the saving and uplifting of humanity.

Article 3. This Association shall be composed of messengers from its several churches on the following basis: Three messengers from each church, and one additional messenger for every twenty-five members or major part thereof, in excess of fifty members, and one messenger each from the auxiliary bodies of the church.

Article 4. The messengers shall present to the Association letters certifying their appointment, and giving also the statistics of the church and its auxiliaries for the current year.

Article 5. Whenever the messengers appointed by a church shall fail to attend, or the number is not equal to the representation allowed by the constitution, the Association at its discretion may accord seats to another member present from said church.

Article 6. The officers of this Association shall be a Moderator, Clerk, and Treasurer, who shall be elected annually by ballot, and by a majority vote, but the Association may by a unanimous vote, instruct someone to cast the ballot for the body as a whole.

Article 7. The duties of the Moderator shall be to preside, keep order and appoint all committees not otherwise provided for.

The Clerk shall keep the records of the Association, supervise the printing and distribution of the minutes, and keep a regular file of the published proceedings of the Association, and deliver same to his successor in office.

The Treasurer shall keep a correct account of all the money received and disbursed by him, paying out the same only on the order of the Association or its Executive Committee, and report in full the

transactions of his office at each annual session of the Association.

Article 8. The business of the Association shall be transacted ad-interim by an Executive Committee consisting of seven members to be recommended by the Committee on Nominations, and approved by the body. The Moderator and Clerk of the Association to be members ex-officio, of the Committee.

Article 9. The annual meetings of this Association shall begin on Wednesday before the third Sunday in October, and by appointment there shall be preached an introductory sermon on the first day.

Article 10. Newly organized churches may be admitted into the Association on petitionary letters presented by their messengers, accompanied by a certificate of the presbytery as to their orthodoxy and proper organization.

Article 11. This Association shall be advisory only in matters of controversy between members of any of the churches or between different churches, but reserves to itself the right to withdraw fellowship from any church which it deems disorderly or heterodox, and concedes to its constituent churches the right to sever their connection with this body whenever they shall apply for letters of dismissal from the Association.

Article 12. The Moderator shall at each session appoint Chairman of Committees on the following subjects, to-wit:—

State Missions.

Home Missions.

Foreign Missions.

Education.

Orphanage.

Woman's Work.

Baptist Young People's Union.

Sunday Schools.

Periodicals.

Obituaries.

Present-day Evils.

And such other questions as the Association

may deem proper.

Article 13. All messengers, officers and members of the Executive Committee shall be members of some of the churches composing this body.

Article 14. When any church neglects to send up statistics to the annual meeting, the Clerk shall insert the last reported total membership in the column containing said statistics.

RULES OF DECORUM.

1. The first meeting of each annual session of the Association, the Moderator of the previous session shall call the messengers to order. After singing and prayer, he shall declare the Association ready for business—the first item being the election of a Moderator and Clerk, after the messengers have enrolled their names. In case of the absence of the Moderator, the messengers present shall elect a Moderator pro tem. who shall proceed as aforesaid.

2. Each meeting shall be opened and closed

with singing and prayer.

- 3. The Moderator shall preserve order and decide all questions in debate, subject to an appeal to the body, and when speaking on any subject, shall call some member to the chair, and in case of a tie, may give the deciding vote.
- All committees shall be appointed by the Moderator, subject to the vote of the body.
- 5. The Clerk shall keep a complete record of the proceedings of each meeting and in the absence of the Moderator, shall call the Association to order and preside until a Moderator pro tem. is elected.
- No business shall be transacted without a quorum which shall consist of a majority of the registered members.
- 7. All members wishing to speak shall rise and respectfully address the Moderator, confine themselves strictly to the subject, and no unkind allusions shall be made while speaking.
- 8. No motion shall be debated until seconded, nor voted upon until stated by the Moderator or read by the Clerk.
- When a question is under debate, no motion shall be received, except to adjourn, lay on the table, amend indefinitely, postpone, refer to a committee, or otherwise, call previous question.
- 10. Any member in the majority may move a reconsideration at any time during the session.
- 11. The rules of decorum may be amended at any annual session of the Association by a majority yote of all the members present.

Articles of Faith.

Purpose: To set in order a declaration of those things most surely believed among us. Luke 1:1.

Article 1. We believe in one only true and living God, and that there are three persons in the God-head—Father, Son and Holy Spirit. 1st King 8:60; Isaiah 44:6; Matt. 28:19; John 10:30; 14:16.

Article 2. We believe that the Scriptures of the Old and New Testaments are the Word of God and the only rule of Faith and Practice. Deut. 4:2; 12:32; Matt. 15:9; Luke 11:28; John 14:15; 2nd. Timothy 3:16; 1st. Thess. 2:13; 1st. Peter 4:11; Revelations 22:19.

Article 3. We believe in the doctrine of Original Sin. Gen. 3:5; Psa. 51:5; 1st. King 8:46; Rom. 3:9; Gal. 3:22.

Article 4. We believe in the total depravity of the human heart and that the natural state of man is such that he cannot recover himself from his fallen and ruined condition. Psa. 53:1; Jer. 13:23; Rom. 8:7-8; John 3:3; Micah. 6:7; Gal. 3:10-11.

Article 5. We believe in Election according to the Fore-knowledge of God, through Sanctification of the Spirit, and Belief of the Truth. Deut. 7:6; Acts 22:14; 13:46; Romans 8:29-30; Eph. 1:4; Matt.

24:31; John 10:16; 6:37; Romans 9:15; 2nd Tim. 1:9; Titus 1:1-2; 1st. Peter 2:9.

Article 6. We believe that the Grace of God that bringeth Salvation hath appeared unto all men, and that nothing prevents the Salvation of the vilest sinner, but his own voluntary rejection of that Grace. Titus 2:11; John 3:16-18.

Article 7. We believe that sinners are Justified only by Faith in Jesus Christ. Romans 5:1; Isaiah 53:11; Acts 13:38-39; Romans 10:4; 3:25-26; 1st. Cor. 1:30; Gal. 3:21-24; 2:16.

Article 8. We believe that the Gospel of Christ is the means of Divine appointment to bring Sinners to Repentance and Faith in Jesus Christ, and therefore should be preached to all men everywhere. Matt. 28:19-20; Acts 4:12; Romans 1:16; Acts 16:31.

Article 9. We believe that the Saints shall persevere in Grace and never finally fall away. John 10:27-29; 17:9-12; 11:25-26; Romans 8:31-39.

Article 10. We believe that Baptism and the Lord's Supper are Ordinances of Jesus imposed upon His Church. Matt. 28:19-20; Luke 22:19.

That nothing is Baptism but immersion. Matt. 3:16.

That believers are the only proper subjects of His Ordinances. Matt. 3:7; Acts 8:36-38.

And that none but Baptized believers are entitled to partake of the Lord's Supper. Acts 2:41-42; Matt. 26:20-30; Mar. 14:17-26; Luke 22:14-18.

Article 11. We believe in the Resurrection of the Dead and a General Judgement. Acts 17:31;

1st. Cor. 15:3-4, 20-25; John 5:28-29; Heb. 9:27; 2nd. Peter 3:7.

Article 12. We believe that the Punishment of the Wicked will be Everlasting, and the Joys of the Righteous will be Eternal. Matt. 25:46; 2nd. Thess. 1:9; Mar. 10:30.

REPORT OF THE EXECUTIVE COMMITTEE.

To the Suwannee Missionary Baptist Association, Greeting:-

Dear Brethren:—Your Executive Committee charged with the administration of your affairs adinterim, beg to say that while we have tried to be on the alert and hold ourselves ready for service at any time, yet there have been but few matters to claim our attention, and therefore, not much to report.

You are, of course, aware of the action of our last State Convention, held at Lakeland in December, in abolishing, at least for a year, the old plan of employing an Associational Missionary for each Association and substituting instead a plan for grouping certain Associations most easily accessible, into cooperative districts, and employing an Evangelist for each district.

This seemed to the Convention necessary in order to place within easy reach of the weakest church, as strong a man as could easily be secured; enabling the State Board of Missions to pay larger salaries and thereby procure stronger men than could be done by the employment of the larger number of men employed under the old plan.

Your Committee being in full accord with the Convention, held a meeting at Live Oak, at the Auditorium on January 10, 1913, and decided to cooperate with the Executive Committee of Beulah Harmony and Central Associations, and at a joint session of committees of these three Associations with ours, held at Live Oak on January 17th, Rev. S.

S. Mathis, former pastor of the First Baptist Church of Jasper, was unanimously elected as our Evangelist, and was commissioned by the Board and began work on March First of this year.

Brother Mathis has waged a vigorous campaign and has given to our Association a liberal share of his time.

He has given the pastors and churches some valuable assistance in Evangelistic meetings as well as to subserve the interests of our work in general. For a fuller account of his work you may refer to his report, which will doubtless follow.

It was further made to appear to us that Rev. B. D. Harrell was entitled to an interest in the aged minister's fund. We recommend that he be put on the aged minister's list.

An appropriation was also recommended for the Rose Mary church for \$125.00 to aid them in erecting and completing a new building.

It is with peculiar pleasure that we call your attention to the new church building of the Jasper church, which is now complete and in which we are assembled, and appreciate the further fact that the building has been erected without aid from any agency of the denomination.

We note with sorrow, however, that the two strongest churches of the Association are without pastors, Brother Mathis having resigned at Jasper on March 1, and Brother W. R. Ivey, a prominent member of this committee having left the Live Oak church and the State, on October 1. May the time soon come when these two churches shall be manned

by strong men, and other churches in our Association, who are pastorless, find the right leader.

We believe that we are rapidly coming to a new day—a day of progress and achievement in the Kingdom of Christ, and we pray that the Suwannee Association may take her place in the front rank among the Associations of Florida.

Recommendations.

We desire to recommend:-

- 1. That the Association urge the pastors of the leading churches and the leading laymen in all our churches to arrange and assist in every way possible in holding Missionary Institutes and Rallies for the purpose of disseminating Missionary information and generating Missionary enthusiasm, that our churches may become Missionary in FACT as well as in name.
- 2. That each church shall undertake immediately upon the beginning of the new fiscal year, the raising of a definite sum for the various objects fostered by our State Convention, and that the new Executive Committee make an apportionment to every church, asking for a definite sum and prorata share of our obligations.
- 3. We earnestly request each church to send messengers from among its young people, and Sunday School officers to the various meetings of our Sunday School Conventions.

- 4. That every member of the Association pledge his hearty assistance to the clerk in completing a roll of the churches of our Association, in order that the Executive Committee may be able to get in touch with inactive and non-contributing churches.
- 5. Last and greatest and most important let every church and every member see to it, that a liberal offering is made for State Missions and same forwarded to Dr. S. B. Rogers at Gainesville, at once.

Report on Foreign Missions was read by Bro. Mathis, as follows:—

REPORT ON FOREIGN MISSIONS.

Jesus said to His disciples: "All authority hath been given unto me in Heaven and on earth. Go ye therefore and make disciples of all the nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit: Teaching them to observe all things whatsoever I have commanded you; and lo, I am with you always, even unto the end of the earth."

In response to this command the Missionary Baptists of the South contributed to Foreign Missions last year \$566,371.64, all of which was expended in the futherance and maintenance of our Foreign work.

Of this amount, Florida's offering was \$9,965.32 of which the Suwannee Association, according to our year book, gave \$184.00. Two churches of the Association contributed \$160.55, leaving a balance

of \$23.45 contributed by all the approximately 28 other churches combined, an average of less than \$1.00 each, but perhaps this is hardly a fair comparison, for out of those 28 churches only six gave anything at all, there being only eight churches in our Association that contributed to Missions last year. In other words, two and one-half million Southern Baptists gave 22½ cents per capita.

While approximately 700 Suwannee Association Baptists gave less than eleven cents per capita.

"Will a man rob God?" asked the prophet, and when the people said "How have we robbed Him?" he answered: "In offerings," and verily it must be true today.

Brethren, deplorable as these facts are, when considered in the face of His Command, yet they will not be much improved upon, until the Spirit of our Master so seizes and holds us that His Cause shall have the place it deserves—first place in our hearts and plans, and causes us to bestir ourselves to action in behalf of the lost in our own homes, State and Nation.

"Let your light so shine among men"—which men? All men from Jerusalem to the uttermost parts of the earth, "that they may glorify your Father who art in Heaven."

REPORT ON HOME MISSIONS.

Of all the agencies employed in the carrying out of the Great Commission, there are none, nor indeed can be none more important than the work of the Home Mission Board. The very name "Home Missions" should enthuse the heart of every Southern Baptist. It means the protection and sanctity of the home in our beloved Southland.

Much more it means the salvation of our loved ones, our friends, and the stranger within our gates. In fact it stands for the salvation of a lost world. Strengthen and fortify our Baptist cause at home, and we are prepared to give it to a dying world.

It has been said that "As goes America, so goes the world," and "Goes the South, so goes America." We believe this is true with reference to Baptist principles. Nowhere on earth have Baptist principles flourished and conquered as in our own South.

Then how great the responsibility of Southern Baptists, of Florida Baptists, of Suwannee Baptists? By the aid of the Home Board, we are able to combat the heresies of papalism and paganism that are constantly landing on our shore through the great flowing tide of emigration. Through the assistance of Home Missions many once weak and homeless churches are now strongholds in our Lord's Kingdom.

By the Home Board our State and Associational Mission Work is much strengthened. When we consider all this and then look at the financial table of our Suwannee Missionary Baptist Association, we are shocked at the indifference of our churches.

In 1912, the workers employed by the Board reported 26,899 baptisms; total additions to the churches, 47,728; 683 churches constituted and 754 Sunday Schools arganized. More than two Sunday Schools and nearly two churches for every day in the year!

Then there is the mountain school work, the department of evangelism, our work in Cuba and the Canal Zone, and the work among the negroes all carried on by the Home Board. Yet in the face of the fact that the Board has done so much and that so much more needs to be done, only ten of the thirty churches in our Association contributed to Home Missions last year, and their offerings were small—a total of \$226.00.

We have several churches who ought alone to have given more than this amount. We earnestly recommend that every pastor in our bounds take and

read and try to get each member in their fields to take and read our Home Field. That each pastor pray for the guiding influence of the Holy Spirit, and that they be obedient to the Spirit in dealing with the great question of Missions.

REPORT OF COMMITTEE ON SUNDAY SCHOOL AND YOUNG PEOPLE'S WORK.

Report on Sunday Schools and Baptist Young People's Work was read by Brother Murrow, as follows:—

Young People's Work is one of the most important obligations laid upon us by the Master. "Train up a child in the way he should go and when he is old he will not depart from it." Prov. 22:6.

"And ye fathers provoke not your children to wrath; but bring them up in the nurture and admonition of the Lord." Eph. 6:4.

From these we have the obligation and the command. Others feeling this resting upon them to such an extent that they were burdened with the desire to solve the problem of the training of the young, organized and put into work some twenty years ago, the training school of the Church—the B. Y. P. U.—and now there are in the South over twenty-five hundred Unions in connection with the various churches training for service the young people in their respective communities.

How many in Florida?

How many in this Association?

These should be important question for us. G. E. Mabry, of Tampa, is President, and George Hyman, now of Sanford, is Secretary of the B. Y. P. U. of Florida. The State is divided into four districts, and Conventions are held in each for inspiration and suggested plans for bettering the work of the local Unions.

A yearly Encampment is held at Lake City, on the Grounds and in the Halls of Columbia College, which partakes of the Chautauqua idea and is indeed one of the livest factors in giving inspiration to the work that we have in the State.

We recommend that each Church within the bounds of this Association organize and maintain a Baptist Young People's Union, the training service of the Church, so that our young may grow into

manhood and womanhood willing, anxious and ready to do the Master's service in this His vineyard.

The Sunday School is not displaced by the B. Y. P. U., but is really aided by it, in that teachers and officers for the Sunday School are found more readily and better prepared among those who have been in the B. Y. P. U., the training School of the Church.

The Sunday School is needed and cannot be displaced, for it is the Teaching Service of the Church. The Bible—the Word of God—is taught there and that exclusively, or should be. Christ's command "Teaching them to observe all things whatsoever I have commanded you," and "Study to show thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the Word of Truth," are before us.

What better way can we comply with these commands from the Inspired Word than that which has been organized and become an indispensible part of the Church Work—The Sunday School?

Statistics show that a vast majority of the conversions come from the children of the Sunday School. So then, in teaching there are two things to be considered. Teaching the believer the more perfect way that he may be rooted and grounded in the Faith, and teaching the unbeliever that he may realize the fullness of the love of God, and become as a little child.

Out of the 21 churches reporting to the Association last year, only ten report any Sunday School, only two report any conversions, and only one report any contributions. These same churches re-

port 566 scholars with 70 teachers from a Church membership of 1,274, showing less than half of the Church membership as being at all interested in the systematic and organized method of studying and teaching God's Word. This should not be. Oh! for a closer walk with God.

The State Board has employed for several years a man to look after, properly organize, systematize and encourage this department of the work of the Church. Training classes have been organized and men and women all over the State are preparing themselves for more effective work in the teaching service.

We beg to note one more advance which is proving the wisdom of such, in the organizing of a Sunday School Convention, holding its sessions on the fifth Sunday and the two or three days before.

These are inspirational, uplifting and very beneficial, not only to the School itself, but to the whole community in which it is held. We recommend most heartily the continuance of these Conventions, and urge upon all the Churches to organize a Sunday School for the purpose of studying God's Word and doing it systematically and intelligently, and that each school have a large representation at each Convention.

The development and instruction of these natural faculties is what we know as education. The man of business and the professional man, who have an education, are better equipped to meet the business and professional problems than the unlearned man. The farmer and the machinist, who are possessed of technical learning, can do better and more effective work, each in their particular calling, than the man who has had no advantages. The Christian, whether he be layman or pastor, can study the Word of God with greater intelligence, and can impart to others the knowledge he has acquired with more clearness and effectiveness, if he or she be educated.

We believe that Christian education is one of the most vital forces in the world for good, and is sweeping the world onward and upward. We cannot too highly regard this God-given gift, for Christian education fits a man or woman for all the spheres of life, both religious and secular, for the home, for society, for business, and to do the work so much needed in the religious field and in our churches.

Our denominational schools and colleges are the only reliable source from which we draw our forces for State, Home and Foreign Missions. Close

our schools, and we would soon be as ignorant as we were one hundred years ago. The uneducated man cannot resist and defeat the present day assaults made upon Christianity, and especially upon Baptist interpretation of the Bible by the quick-witted and advanced thinkers of our enemies. We must support and give our patronage to our Baptist schools and colleges.

The schools of other denominations will not supply us with the training we need, and are not safe and reliable guides for our young men and women. The State Schools do not give us this training, because the law forbids religious instruction in public schools. The necessity is upon us. We must educate or retrograde.

We are leading all other denominations in the South today because we are giving a larger and more loyal support and patronage to our Baptist Schools than any other denomination does to theirs.

We commend to this Association our much beloved Columbia College. We ask that you give to it liberally of your love, of your money, and of your children. The College will take your gift of love, and will use it in loving kindness to the children you send us, and in affectionate care of their minds and bodies. Your gift of money will be used for the upbuilding of this already great College property, and its proper equipment for the work required of it. The gift of your children will be used by the College as most worthy material from which to turn out from its gates boys and girls who shall become the men and women of the future, reflect honor and

REPORT ON PRESENT-DAY EVILS.

The report of the Committee on Present-day Evils was read by Rev. S. S. Mathis, as follows:—

If your Committee on Present-day Evils interpret the signs of the times aright, one among the greatest evils of the day is the flagrant violation of the law. With our advanced civilization and ever increasing facilities for education, it would not be unnatural to expect a law-abiding citizenship, but an earnest look at the situation can but cause the thoughtful person much concern.

Perhaps there has never been a day when there was less violation of law by the so-called lawless element, nor when criminals of low and high rank were being brought to a more speedy justice; but the danger that confronts us today is the "petty" violations of law by those who are regarded as lawabiding citizens.

There are constant and flagrant violations of our game and fish laws—little things in themselves they may seem—but breeding in the heart of the violators, as well as in the growing youth, that general disregard for law, which finally undermines our civilization and the State and Nation itself.

It may, perhaps, be granted that there are many laws upon our statutes that are not worthy of our respect, but our judiciary is clothed with proper authority and power to pass upon the validity of law, and it is our part to obey them as they are.

But perhaps the worst of it all lies in the fact that many churchmen are thoughtless of the laws they constantly violate. Brethren, one of the Commandments of the New Testament is that "Ye obey the powers that be," and a high regard for right and a keen sense of honor will impel one to obey the laws of the land.

Another evil that is encroaching upon the rights of Christianity and attempting to undermine our civilization is the disregard for, and violation of the Sabbath. The open dealing in cold drinks and cigars on Sunday by older persons can but bear fruit in the rising generation in an undermining of our religious standards.

The keeping to one day in seven purely for worship of God and the building up of our physical and moral selves, has come to us from before the flood and delivered to us to be transmitted to future generations. Shall we give them a high regard for the Sabbath and high religious ideals, or shall we allow those who have no regard for our holy institutions to tear them down? Let every one bestir himself to the best there is in him for the maintenance of law and the preservation of the Sabbath.

One who does not read and keep informed of the happenings of the day is looked upon as queer and ignorant, and not alive to the best interests of meither his community, his home, nor himself. He cannot converse intelligently with the common school child and is put down as a know-nothing.

These papers named above are disseminators of instruction and kindle enthusiasm and ambition, and arouse genius to produce the wonderful improvements and achievements that have marked this as a progressive age. If these provide such a store of knowledge and do so much for the onward march of civilization in the different phases of life, why not the State denominational paper, the monthly journals sent out by the Boards and the other literature, tracts and etc., receiving our anxious and eager attention that we may know what is going on in the work of the kingdom, that we may be better informed and our enthusiasm kindled and made to

burn with a zeal and energy with a knowledge toward God.

Being informed is one of the highest compliments that can be paid a man today, and being informed in things religious is the duty of every child of God. Does He not say in His own printed page "Search the Scriptures," and "Study to show thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the truth."

It has been demonstrated that a large percent of the knowledge and instruction that people acquire is acquired through the eye. Then how important it is that the professed Christian study, read and study the literature that pertains to his profession. The merchant reads his trade journal and paper and such like. The lawyer his advance sheets and other literature pertaining to his calling, the doctor reads his journals and magazines, and all of them, as well as others, in all professions, invest their money and time in the perusal of the printed page to perfect them in the work of their profession.

If then the profession of Christianity is the most important and vital and eternal profession, and who can deny that it is, then how much more incumbent upon us as professed Christians, to read approved books and magazines and matter that will store the mind with the deep and rich truths of God that we can readily and earnestly contend for the Faith once delivered unto the saints.

It is from a knowledge of conditions that we at all times are prepared to suggest and plan a remedy or propose progress. In order to have this knowl-

edge we must profit by the experience of other organizations and institutions. They have their papers—weekly and monthly, as well as journals and magazines. We must have our weekly paper and monthly magazines or journals reporting the work and the interests, and reciting the plans and purposes of those at the front.

The Baptist Witness, published at Lakeland, the Home Field, published in Atlanta, Ga., and the Foreign Mission Journal published in Richmond, Va., the Sunday School periodicals and lesson helps and the many various and good books published by the many learned and experienced students of these truths, and last, but by no means, least, the Word of God—Holy Writ—gives the information for this upbuilding and far more interesting and compensating than any of the others in their profession, for this is Eternal.

We therefore recommend that each and every family provide themselves with a copy of the Bible, get some part of the Sunday School Board literature for study and so far as practicable, subscribe for and read each of the above named papers or journals and let religious books take the place of those bearing on the weaker and less important subjects of this life.
