#### ARTICLES OF FAITH

Article 1. We believe in one only true and living God, and that there are three persons in the God head, Father, Son and Holy Ghost. — 1 Kings 8:60. Isaiah 44:6. Matt. 28:19. John 10:30, 14:16.

Article 5. We believe in the election according to the foreknowledgment of God through sanctification of the spirit and belief of the truth.—Deut. 7:6. Acts 22:14. 13:46. Romans 8:29-30. Eph. 1:4. Matt. 24:31. John 10:16, 6:37. Rom 9:15. II Tim. 1:9. Titus 1:1-2.

Article 6. We believe that the grace of God that bringeth salvation hath appeared unto all men and that nothing prevents the salvation of the vilest sinner but his own voluntary rejection of that grace.—Titus 2:11. John 3:16-18.

Article 7. We believe that sinners are justified only by faith in Jesus Christ.—Romans 5:1. Isaiah 52:11. Acts 13:38-39. Romans 10-4, 3:25-26. I Cor. 1:30. Gal. 3:21-24, 2:16.

Article 8. We believe that the gospel of Christ is the means of divine appointment to bring sinners to repentence and faith in Jesus Christ and therefore should be preached to all men everywhere.-Matt. 28:19-20. Acts 4:12. Romans 1:16. Acts 16:31.

Article 9. We believe that the saints shall persevere in grace and never finally fall away.-John 10:27-29, 17:9-12, 11:25-26. Romans 8:31-39.

Article 10. We believe that Baptism and the Lord's Supper are ordinances of Jesus imposed upon His Church .-Matt. 28:19-20. Luke 22:19. That nothing is Baptism but immersion.-Matt. 3:16. That believers are the only proper subjects and that the only proper administrators of Baptism are ministers who have been regularly ordained by a church of same faith and order, by the imposition of hands of a presbytery.-Matt. 3:15. I Cor. 11:2. I Tim. 4:14. Titus 1:5. And that none but baptised believers are entitled to partake of the Lord's Supper.-Acts 2:41-42. Matt. 26:20-30. Mark 14:17-26. Luke 22:14-18.

Article 11. We believe in a resurrection of the dead and a general judgment.—Acts 17:31. I Cor. 15:34, 20:25.

John 5:28-29. Heb. 9:27. II Peter 3-7. Article 12. We believe that the punishment of the

wicked will be everlasting and the joy of the righteous will be eternal.—Matt. 25-26. II Thess. 1:9. Mark 10:30.

## CONSTITUTION

Article 1. This organization shall be known as the Suwannee Missionary Baptist Association.

Article 2. The specific object of the Association shall be: a. To unite the influence and pious intelligence of the Baptists within it and thereby facilitate their union and cooperation.

b. To form and encourage plans for the revival of experimental and practical religion and the spread of the gospel within the bounds of this Association and elsewhere.

c. To aid weak churches in our bounds.

d. To encourage and aid the education of our pious young men who may be called by the Spirit and approved by their respective churches for work of the gospel ministry.

e. To promote pious and useful education among all Baptists.

f. To care for the needy orphans among us.

g. To aid in any work whose object is the saving and

uplifting of humanity.

Article 3. This Association shall be composed of messengers from its several churches on the following basis: Three messengers from each church and one additional messenger for each twenty-five members or major part thereof in excess of fifty members, and one messenger each from the auxiliary bodies of the church.

Article 4. The messengers shall present to the Association letters certifying their appointment and giving also the statistics of the church and auxiliaries for the current year.

Article 5. Whenever the messengers appointed by the church shall fail to attend or the number is not equal to the representation allowed by the constitution, the Association, at its discretion, may accord seats to another member present from said church.

Article 6. The officers of this Association shall be a Moderator, Clerk and Treasurer, who shall be elected annually by ballot and a majority vote, but the Association may by a unanimous vote instruct someone to cast the ballot for the body as a whole.

Article 7. The duties of the Moderator shall be to preside, keep order and appoint all committees not otherwise

provided for.

The Clerk shall keep the records of the Association, supervising the printing and distribution of the minutes and keep a regular file of the published proceedings of the Association and deliver same to his successor in office.

The Treasurer shall keep a correct account of all money received and disbursed by him, paying out the same only on the order of the Association or the Executive Committee and report in full the transactions of his office at each annual session of the Association.

Article 8. The business of this Association shall be transacted ad interim by an Executive Committee; this Committee shall consist of one member from each church in the Association. The local church shall elect the member and the Association ratify the selection. The Moderator and Clerk of the Association to be members ex-officio.

This body shall supervise all missionary work in the Association and shall meet in session at least once every three

months at the union meetings of the Association.

Article 9. The annual meeting of this Association shall begin on Thursday before the third Sunday in October, and requesting all churches who hold regular services on the third Sunday and Saturday before to give their pastors their October meeting in each year in order that the pastor may attend the Association and remain there through Sunday and by appointment there shall be preached an introductory sermon on the first day.

Article 10. Newly organized churches may be admitted into the Association on petitionary letters presented during the session of the Association; presented by messengers accompanied by a certificate of the presbytery as to their

orthodox and proper organization.

Article 11. This Association shall be advisory only in matters of controversy between members of any of the churches, but reserves to itself the right to withdraw fellowship from any church which it deems disorderly or hetarodox and concedes to its constituent churches the right to sever their connection with this body whenever they shall apply for letters of dismissal from the Association.

Article 12. The Moderator shall, at each session appoint a chairman of committees on the following subjects, to-wit: State Missions, Home Missions, Foreign Missions, Education, Orphanage, Woman's Work, Sunday School and B. Y. P. U., Periodicals, Obituaries, Present Day Evils, Temperance, and such other questions as the Association may deem proper.

Article 13. All messengers, officers and members of the Executive Committee shall be members of some of the

churches composing this body.

Article 14. When any church neglects to send up statistics to the annual meeting the Clerk shall insert the last report total membership in the column containing said statistics.

#### RULES OF DECORUM

1. At the first meeting of each annual session of the Association, the Moderator of the previous session shall call the messengers to order and after singing and prayer he shall declare the Association ready for business, the first item being the election of a Moderator and Clerk after the messengers have enrolled their names. In case of the absence of the Moderator, the messengers present shall elect a Moderator pro-tem who shall proceed as aforesaid.

2. Each meeting shall be opened and closed with sing-

ing and prayer.

3. The Moderator shall preserve order and decide all questions in debate subject to an appeal to the body, and when speaking on any subject shall call some member to the chair and in case of a tie may give the deciding vote.

4. All committees shall be appointed by the Moderator,

subject to the vote of the body.

5. The Clerk shall keep a correct record of the proceeding of each meeting and in the absence of the Moderator shall call the Association to order and preside until a Moderator pro-tem is elected.

6. No business shall be transacted without a quorum. which shall consist of a majority of the registered mem-

7. All members wishing to speak will rise and respectfully address the Moderator, confine themselves strictly to the subject and no unkind allusions shall be made while speaking.

8. No motion shall be debated until seconded, nor voted upon until stated by the Moderator or read by the Clerk.

9. When a question is under debate no motion shall be received except to adjourn, lay on table, amend, indefinitely postpone, refer to a committee or otherwise call a previous question.

10. Any member in the majority may move a reconsideration at any time during the session.

11. The Rules of Decorum may be amended at any annual session of the Association by a majority vote of the members present.

#### Report on Education

Your Committee on Education beg to report:

The interest of our State, as represented in the Legislature, in the matter of education, was so great that they passd a law which compells parents to send their children to the public schools, to the end that every child in Florida shall have an education, at least in part. This indeed is well, and we urge upon the members of our denomination their full support and hearty co-operation in the enforcement of this law Our public schools are reaching an efficiency heretofore unknown, and their influence is becoming more potential in church and State. Recognizing, as we do, the inviolate principal of separation of church and state, we also recognize the necessity of strict vigilence on the part of the Christian leaders in each community in order that our public schools may have no teacher who makes

light of Christianity and the Bible, since belief in God and the Bible is the chief cornerstone of our great republic.

If the great State of Florida has put her stamp of approval on education, as to secular learning, and urges upon her citizens the careful training of the children, how great then should be the concern of every Christian in the spiritual education of his child, that the Word of God and the holy teachings of our Lord and Savior, Jesus Christ, shall enter into the mind and heart, and lead them to the cross and the service of the Master. Let every Baptist within the bounds of the Suwannee Association make this resolve, "That we will observe the daily reading of the Bible, with the family assembled for worship, and will erect an altar in our homes, where prayer shall be made and, upon bended knee, we shall lead the children to pray, and our Father in Heaven will bless our effort.

In the denominational schools and colleges the guarantee is given that education shall be for the whole man—soul, mind and body. The only guarantee of Christian education is in the denominational school. Private schools may or may not be Christian A Baptist school or college, owned and directed by the Baptist churches through a board of trustees, may and should know the faith and practice of the teachers, and no man or woman should be employed whose loyalty to the doctrines of the Bible, and the faith and practices of Baptists, is not well known to be sound and active.

The purpose of the Baptist schools and colleges is to train leaders for the pulpit and the pew, and while we want to emphasize the fact that a Baptist school or college is not a Theological Institution, but a place to fit young men and women for all the different walks of life. It also gives them that Christian training needed in the life of every man and woman That denomination will have the greatest success today in service within our homeland and in foreign fields, which has the largest number of consecrated, educated leaders, trained into efficiency in the service of God. Such laders are needed in the country and village churches, and the need is just as great in the towns and cities.

Therefore Baptists should educate, and your committee urges upon every Baptist faithful and earnest effort in the education of his children.

#### Report on Sacred Literature

If there was ever a time in the history of Christian civilization when the study of the Bible as a text book should be emphasized, more than at any other time, that time is now. When we look upon the conditions, or the true situation of the peoples and governments of the world today our hearts are saddened and sometimes our faith and hope grow faint. The church and the followers of our Lord Jesus Christ have a most stupendous struggle confronting them if they are to combat the forces of evil, and the open attacks and assaults now being made upon the church and the Gospel of Jesus Christ. There are many false teachers throughout our land today who are openly or covertly seeking to undermine all that Christian civilization has accomplished and to overthrow the high ideals of Christian civilization. The spirit of unrest and anarchism and revolution is casting a dark pall over the wirld. Political governments have been unable to successfully suppress the propaganda.

We believe that there is only one solution, one unfailing remedy for this crisis now confronting the world, and that is to be found in the teachings of the Bible and of the religion of the Christian people. We believe that there is no question so troublesome to the human race, or so perplexing to the governments of the world, but that the remedy can be found now by a careful study of God's laws as revealed to his chosen people and by careful study of the teachings of our Lord Jesus Christ

So your Committee would earnestly urge that the church and Christian people everywhere lay more emphasis on a systematic study of the Bible Let "back to the Bible" be our watchword. #### Report on Orphanage

The statement of James, (pure religion and undefiled before God is this; to visit the fatherless and widows in their afflictions), has found expression among the Baptists in the beautiful home we have established for our boys and girls at Arcadia, Florida.

To the credit of our brotherhood it can be said that what we have done for our boys and girls, we have done well. As a result of the past fifteen years work we have a home that consists of eighty acres, of land, twenty-five in cultivation, and eight in an orange grove, three two-story brick buildings, one frame building, namely, girls' building, dining hall, and large boys' dormitory, school room and middle-sized boys' dormitory, Maxey Memorial babies' building and superintendent's home, the Memorial hospital building in the course of construction, also out buildings. The family in this home consists of one hundred, and eight helpers. It costs about \$ 5.00 per child a month to pay the current expenses of the work, including clothing, food supplies, schooling, helpers, salaries, medicines, etc.

We have our own school in the home with two teachers and all children six years old and up attend school. As industrial work we have a farmer who trains the boys in farming and gardening. We have a cannery, printing office, carpenters, blacksmith and paint shop, a poultry farm and up to date concrete block and brick plant. Shorthand is also taught in the home and we have a sewing room, laundry and dairy. There can be no thought of children being brought up in idleness in such a home. They receive the very best

of training to make them useful men and women. The children all attend Sunday School and church at the First Baptist Church, Dr. A. J. Holt, pastor. And with the exception of two or three, all who are old enough to consider the matter are Christians and members of the church. The home's greatest need is donations, and Supt. Trice assures us that either money or supplies will be appreciated.

We, your Committee, urge that the members of the Suwannee Association take thought of the Florida Baptist Orphanage and contribute liberally of their means to its support.

#### Report on Present Day Evils

Brethren: We beg to report as follows, taking as a basis, Idleness, Obstinacy, Averice, Hypocrisy and perhaps a few others.

Idleness-Idleness is the bone (the poison) of ruin, destruction and injury, of body mind and soul, the nurse of haughtiness, the chief author of mischief, one of the several deadly sins, the cushion upon which the devil reposes and a great cause not only of meloncholy. but many other diseases as well as crimes. Of all contemptible things there is nothing half so wretched as a lazy man. The Turk says the devil tempts everybody, but the idle man tempts the devil. We are aware of the fact that a man can be a professional loafer, a successful loafer, with less capital, less brains than are required to succeed in any other profession. Idleness is an ingredient of the upper current which was scarcely known and never countenanced in the good old days of our Pilgrim Fathers and Revolutionary Patriots. We have those who would rather go hungry and clad in rags than to work. We have a train of idlers who pass down the stream of life at the expense of their fellow travelers, they live well and dress well as long as possible by borrowing, swindleing, stealing, and robbing and often pass for years before justice overtakes them. So long as a man keeps up appearance and eludes the police they are received into the best society. Many an idle knave by means of a fine coat, a lily hand, graceful bow is received into the best society, and walks rough over 'a worthy mechanic or farmer who had too much good sense to make a dash or imitate the monkey shines of an itinerant dandy, a fine dress in the eyes of some covers more sin than charity, an idlesome young spendthrift in a community does more real harm than an old miserable miser. Laziness grows on people, it begins in cob webs and

ends in iron chains. In reading the Bible we read that God labored, that Christ was known by many as the son of the carpenter, and we presume worked at the trade, we are informed by the Bible that he was obedient to his parents. Matt. 20:6, we find this, "Why stand ve there idle all the day." Jesus, in the selection of his disciples did not choose them from among idlers. In Timothy 5:12-13, we find having damnation because they cast off their first faith, and with all they tearned to be idle, wandering from house to house, not only idlers, but tattlers also, and busy-bodies, speaking things they ought not to. Thess. 3:10, for even when I was with you, this we commanded you that if any would not work neither should he eat. Provergs 19:15, slothfulness casteth into deep sleep, an idle soul shall hunger. Prov. 31:27, she looketh well to the ways of her household and eateth not the bread of idleness. Matt. 12:36, but I say unto you that every idle word that men shall speak they shall give account thereof in the day of judgment. Eccl. 10:18, by much slothfulness the building decayeth, and through idleness of the hands the house dropeth through. Ezkl. 16:49, behold this was the iniquity of thy sister, Sodom's bride. fullness and bread, and abundance of idleness was in her and in her daughters, neither did she strengthen the hand of the poor and needy.

Bolshevism.—Reduced to its simplest form is merely a lazy man's envy of the prosperity of the hustler. Oh, how sad it is to see so many church members idling off their time. A good many scarcely know they are members of the church, as it has been so long since they attended church service and took any part in it.

Obstinacy.-Some are so obstinate that when you send a visiting committee to see them in reference to not attending church conferences that they will say, well I have lost interest. In fact a good many will say they have no voice in the thing no how. No wonder he has lost interest, he is not reading his Bible nor his church paper nor is he taking any interest in Sunday School or any auxiliary of the church, and is not open to conviction of any of his wrongs or errors. An obstinate man does not hold opinions, they hold him. For when once possessed of an error it is like a devil, only cast out with difficutly. Whatsoever he lays hold on like a drowning man, he never loosens. Narrowness of mind is the cause of obstinacy. We do not easily believe what is beyond our sight. We all should read, study and pray the more. Of all disagreeable people the obstinate are the worst. When an idea is brought to such people, instead of getting atl the good they can out of it, they seek to show all the bad and are

Hypocrisy.—There is no folly in the world so great as to be hypocritical. The hypocrit is hated, hated by the world for seeming to be a Christian, he is hated by God for not being one, he hates himself and is even despised by satan for serving him and not acknowledging it. They serve him better than any other but receive no wages.

ever ready to heap a mountain of difficulties upon it.

They submit to greater mortifications to go to hell than the most sincere Chrisian to go to Heaven. Let us ask ourselves seriously and honestly what do I believe after all, what manner of man am I after all, what sort of show should I make after all. If the people around me should know my heart and all of my secret thoughts what sort of a show then do I already make in the sight of Almighty God. Take your Bible concordance and hunt up the references to hypocrisy, hypocrit and hypocritical, as they are too numerous to mention in this article.

Averice.-Averice, I believe, is a companion to idleness as far as sin is concerned. The miser starves himself knowing that those who wish him dead will fatten on his hoarded gains, he submits to more torture, to lose heaven, than the martyr does to gain it. He worships this world but repudiates its pleasures, he endures all the misery of poverty through life that he may die in the midst of wealth. He heapeth up riches and knoweth not who shall enjoy them. He defraudeth not only other men but his own genius. Charity is accounted no grace with him and gratitude no virtue. His mind is never expanded beyond the circumference of the almighty dollar. He thinks not of his immortal soul, his accountability to God, or his final destiny. He is an Ishmael in a community. He passeth to the grave without tasting the sweets of friendship, or the delights of social intercourse. The first voluntary expenditure upon his body during his manhood, and the first welcome visit of his neighbor, are both passive on his part, or at his funeral. If we are to enjoy the comforts of life rationally we must avoid the misery of averice and the evils of prodigality. Let's use the provision, of our benevolent benefactor, without abusing them and render to him the gratitude which is due him. Banish all inordinate desires after wealth. If gain is abundantly, be discreetely liberal, judicially benevolent and if your children have arrived at their majority, die your own executor.

Benefactors or Malfactors.-We mention both to clear the point more fully, for we are all well doers or evil doers None of us liveth to himself, we die but leave an influence behind us that survives us. Every one is a missionary now and forever for good or for evil, whether he intends and designs it or not. The seed sown in life springs up in harvest of blessings or harvest of sorrow. Whether our influence be great or small for good or evil it lasts, it lives somewhere within some limit and is operative where it goes. The graves buries the dead dust, but the character walks the earth and distributes itself a benediction or a curse among the families of mankind. We are living in an age of cisms and isms, and we should all be careful of the impression made by each of us as we pass through life only one time. Look for a moment at the industrial strife of today. There should be a medium where by employer and employee could settle their difference amicably, and to the satisfaction of all for . there is a third party concerned, the public It seems that public officials are striving to appease employees just now more than any one else, and still allow them to strike causing choas, terror and bloodshed, and fear to stalk our land, causing the price of Southern produce to drop below cost of production, and best as we can see and learn German propoganda for supremacy of commercialism of the world is at the root of the whole of it and would request all that instead of buying German-made toys just recently shipped to this country by the thousands of tons for the first time in five years, to pledge and give it in a 75 Million Baptist Campaign that is now on. We would like to mention the evil of automobile joy-riding. We often read of some mother's daughter being found near the roadside or in some park dead. In Florida a mother and daughter were burned to death in a car by her daughter's seducer. In Virginia, a young wife is killed while out joy-riding with her estranged and jealous husband. From California reports a young man while out autoing killed his sweetheart that he had already disgraced because she refused to become the mother of his child, and many others too numerous to mention. So, mothers, know who your darling daughter is out joy-riding with. If we had the proper teaching in our churches, Sunday Schools and good community or church libraries and the proper training in our literary schools we would have attraction for our young people and they would not be seeking pleasure elsewhere at such places, pernicious joy-riding on Sunday afternoons, or going in swimming and to the various dances and other gatherings where various orders of amusement and foolish sport and laughter are indulged in. One reason of a great deal of unrest, discontent,, unprogressiveness ism and cisms of today, is the failure of the people to
