

CONSTITUTION

Section 1 This, Association shall be known as the Beulah Baptist Association.

Section 2. This Association shall be composed of Messengers selected by the several Churches connected with the Association. Each Church shall be entitled to one Messenger at large and one for every twenty-five members or majority fraction thereof.

Section 3. Any regular organized Baptist Church of the same faith may become a member of this Association upon application by a petitionary letter and Messengers as above provided.

Section 4. On the second or last day of each Annual Session, the Association shall from its membership elect by ballot a Moderator, Vice Moderator, Clerk, and Treasurer whose terms of office shall begin with the adjournment of the body and extend through the next year and through the sessions of the next year.

Section 5. The object of this Association shall be: First, to promote unity and brotherly love among the Churches; second to promote Gospel discipline; to encourage the universal spread of the Gospel and practical religion throughout our bounds and elsewhere.

Section 6. The Moderator shall appoint at each Annual Session of the Association an Executive Committee composed of one member from each church connected with the Association. Each Church is expected and is urged to recommend its members on this committee. Resident pastors, Heads of the Associational Training Union, Sunday School, Woman's Missionary Union, and Brotherhood departments together with the Elected Officers of the Association shall be ex-office members of the Committee. Their duties shall be: First, to inquire into destitution within our bounds; second, to make contracts with the Ministers of the Gospel of this Association, or other Associations in correspondence with us; to supply such destitution with the Gospel; third, to draw from the treasury for such funds as are available for missionary purposes to meet their contracts, and to exercise general supervision in the promotion of unity and brotherly love among the Churches and the universal spread of the Gospel throughout our bounds. They shall report the results of their labors at each annual session of the Association.

Section 7. The Moderator shall invite correspondence and visiting ministers and brethren to seats with the body when in session. They shall be entitled to the privilege of alding the Association with their counsel.

Section 8. This Association shall have the right to withdraw from any church that may be in disorder when the same cannot be restored by Gospel discipline to the unity of faith in the bonds of peace.

Section 9. The Annual Meeting of this Association shall be held at such time and place as may be designated by the body; and by appointment there shall be an introductory sermon preached the first day of the session at 11 o'clock, and a collection taken up for missionary purposes on Sunday or the last day.

Section 10. This Association shall not lord it over God's heritage nor infringe upon any of the internal rights of churches, but shall act only as an advisory body.

Section 11. This Constitution may be amended at any regular session of the Association by a two-thirds vote of all messengers. Any amendment offered shall be in writing.

RULES OF DECORUM

Article 1. At the first meeting of each session of the Association, the Moderator shall call the Messengers to order the letters from the churches shall be presented and the names of the Messengers enrolled. In case of absence of the Moderator, the Vice Moderator or the Clerk shall call to order.

Article 2. Each day's session of the Association shall be opened with prayer.

Article 3. The Moderator shall preserve order and decide all questions in debate, subject to an appeal to the body; and when he shall speak on any subject in discussion he shall call some member to the chair, and in case of a tie, shall give the deciding vote.

Article 4. The Moderator shall appoint all committees, subject to approval by the body.

Article 5. The Clerk shall keep a careful record of the proceedings of each meeting, prepare and edit the Minutes for printing. In the absence of the Moderator and the Vice Moderator, he shall call the body together and preside until a Moderator pro tem shall be elected.

Article 6. All members wishing to speak on any subject shall rise and address the Moderator as "Brother", and shall confine themselves strictly to the subject and shall not be allowed to make an unkind allusion to any brother while speaking.

Article 7. No motion shall be debated until seconded and stated by the Moderator or read by the Clerk.

Article 8. When a motion is under consideration no other motion shall be entertained except to adjourn, lay on the table, to amend, indefinitely postpone, refer to committee or call for the previous question.

Article 9. Any member voting with the majority on any question in debate may move a reconsideration at any time during the session

Article 10. Visiting brethren of other Associations may speak on any subject, but shall not vote.

Article 11. No brother shall speak more than twice on a subject without the consent of the Association.

Article 12. These Rules of Decorum may be altered or amended at any regular session of the Association by a majority vote of the members of the body.

BEULAH BAPTIST ASSOCIATION

ARTICLES OF FAITH

- 1. We believe in one only true and living God, the Father, Son and Holy Spirit, and that these are one. (See Matt. 28:19).
- 2. We believe that the Old and New Testament Scriptures are the inspired Word of God and the only rules of faith and practice. (2 Timothy 3:17).
- 3. We believe in election according to the foreknowledge of God, through sanctification of the Spirit and belief of the truth. (2nd Thes. 3:13).
- 4. We believe that the Grace of God that bringsth salvation hath appeared unto all men, and that nothing prevents the salvation of the vilest sinner but his own voluntary rejection of that Grace. (Asa 55:1: Rev. 22:17; Acts 17:30).
- 5. We believe in the depravity of the human heart, and that the natural state of man is such that he cannot prepare himself for divine favors without the assisting grace of God, enabling him to act according to the good pleasure of His Divine Will. (Eph. 2:5; Matt. 18:11; John .1:10; First Cor. 3:5-7).
- 6. We believe in justification by faith, which gives peace with God, through our Lord Jesus Christ. (Romans 5:1-2).
- 7. We believe that the Gospel of Christ is a means of grace to bring sinners to repentance and faith in Jesus Christ, and therefore should be preached to all the world. (John 3:16).
- 8. We believe that all those who are regenerated by the Spirit of God are made heirs of God and joint heirs with our Lord Jesus Christ and that they are kept by the power of God through faith unto eternal Salvation. (Peter 1:5; Rom. 8:28; Phi. 1:6).
- 9. We believe that baptism is the immersion of the whole body in water; that the only proper subjects are described in the preceding section, and the only proper administrators are those who have been regularly ordained by a church of Christ, by the imposition of hands of a presbytery. (Acts 8:36; Rom. 6:4; Read Timothy and Titus).
- 10. We believe that the Lord's Supper was instituted by Jesus Christ to be commemorated by His followers and that none but baptized believers have a Spiritual right to partake thereof. (Luke 22:18, 19, 20; I Cor. 14:26-28).
- 11. We believe in the resurrection of the rightous and the wicked, and that the wicked shall go away into everlasting punishment, but the righteous into eternal life. (Acts 25:15).

PROCEEDINGS OF THE SIXTY-FIRST SESSION OF THE BEULAH BAPTIST ASSOCIATION WITH THE LAKE CITY CHURCH OCTOBER 2-3, 1940.

Wednesday, October 2 Ten o'clock A. M. Devotional service led by Rev. P. Q. Cason.

REPORT ON CO-OPERATIVE PROGRAM, 1940

The Co-operative Program is a scriptural, flexible plan of Southern Baptists for enlisting all our people in an intelligent, systematic and adequate support of all of our various activities, and after being tested for a number of years it has proven definitely successful,

In Florida, the Co-operative receipts are divided as follows: State causes, 65 percent; State Missions, 40 percent; Children's Home, Arcadia, 9 percent; Stetson University, 9 percent; Rogers Building, 5 percent; Student Aid, 2 percent. Southwide causes, 35 percent; Foreign Missions, 171/2 percent; Home Missions, 8.05 percent; Relief and Annuity Board, 3.62 percent; Southern Baptist Theological Seminary, 1.47 percent; Southwestern Baptist Theological Seminary, 1.47 percent; Baptist Bible Institute, 1.47 percent; W. M. U. Training School, .30 percent; American Baptist Theological Seminary, 35 percent; Southern Baptist Hospital, .77 percent; total, 100 percent.

The Co-operative Program is a scientific and logical plan to raise funds, also disburse them, in that it saves the expense and inconvenience of having representatives of the various causes making constant appeals to our churches; but let us keep clearly in mind, while the Cooperative Program is a method to provide money for the support of our work, that we do not give to the Program or for the Program itself, but we give through the Program and according to the Program for the support of missions, education and benevolences.

For our future growth Southern Baptists should increase their gifts to God for His work, both at home and abroad, and we should raise our standard of giving until we meet the needs of suffering humanity and the redemption of lost souls.

We make the following recommendations:

- 1. That we heartily approve of the Co-operative Program and pray God's blessing upon this effort for the systematic support of our denominational work.
- 2. That we urge the membership of all churches to increase their gifts and the churches to observe a fair ration in distributing their funds between local expenses and the Co-operative Program.
- 3. That all Co-operative Program receipts and other denominational funds be sent promptly to the state secretary-treasurer, making checks and money orders payable to Florida Baptist Convention.

MISSION REPORTS. REPORT ON STATE MISSIONS, 1940

Florida Baptists in the long ago heard God's call and moved forward in answer to His command, laying wise foundations in Scriptural matters, upon which has been builded a glorious and enduring structure. State mission work is basic and fundamental. The future welfare of our denomination depends upon our loyalty and enthusiastic support of our cooperative work. A wise and constructive State Mission program is necessary if we faithfully carry out our Lord's command to witness for Him both in Jerusalem and unto the uttermost parts of the earth.

We maintain a strong evangelistic work in the State, and until re-

cently employed three full time evangelists, who have been successful in city, town and country churches all over the state. God has graciously blessed our evangelistic efforts. A large per cent of the work is being done in the village and country churches.

REPORT ON HOME MISSIONS, 1940

Our Christ For Our Country

The strategic point of approach to the world task is the homeland. Christ must conquer in the homeland if we expect to win victories for Him in lands afar. We must make the religion of Jesus triumphant at home if we would make it triumphant abroad.

Making and Baptizing Disciples

The Home Mission Board is giving itself to the task of giving our Christ to our country. The Board believes that the heart and soul of missions is the making and baptizing of disciples. It is therefore majoring on preaching the gospel among the Indians, the foreigners, the Negroes, in the congested sections and centers of our land, and in Cuba and Panama.

The past year has been a year of glorious achievements for Home Missions. We have now 411 missionaries working in 863 mission stations. During the past year we have added 40 to our mission force, opened 93 new mission stations, and acquired 14 pieces of property. During the year our missionaries have distributed 40,362 Bibles, Testaments, and portions of Scripture and 660,847 tracts. They have preached 34,008 sermons, led over 9,000 to make profession of faith in Christ, and received into fellowship with the church 4,672.

There are more unsaved souls in the Southland today than there were when the Home Mission Board was organized in 1845. The spirit of evangelism must recapture the small country churches if our rural areas are preserved from the inroads of unscriptural, off-brand types of religion, and if our rural people are saved for Christ and His Kinddom. May God speed the day when this percentage will be lowered.

REPORT OF THE FOREIGN MISSION BOARD

of the

SOUTHERN BAPTIST CONVENTION, 1940

The war clouds which have been threatening for several years have burst, sending their downpour of destruction and death upon defenseless populations. But even out of the wreckage and ruin, the Son of Righteousness is rising with healing in His wings.

The Foreign Mission Board now has 456 missionaries and 2,900 native workers in the 16 countries in which it is operating. Scattered throughout these fields there are 1,883 churches, of which 1,181 are selfsupporting, and 3,269 outstations. During the past year 18,606 have come into the fellowship of the churches by baptism.

From practically every part of the world there come reports concerning the progress of the Gospel. In recent weeks reports have been

received of the marvelous work of grace in the hearts of Japanese students. In the boys' school 550 declared their purpose to follow Christ, and in the girls' school 531 accepted Him as their personal Savior.

Although Europe and the Near East are torn and bleeding, our missionaries are staying by the staff and the Lord is blessing their labors. May we, as God's people, recognize the fact that God is depending upon us as His people to carry on the work He has left us to do.

REPORT ON W. M. U. WORK

The Annual W. M. U. Associational meeting was held at White Springs Church, Monday, September 30th. While the number of churches represented in this meeting was disappointing, we do feel that it was a meeting of great inspiration and spiritual uplift for our women.

With an abiding conviction that "we cannot go further until we go deeper," we continue to place emphasis on Stewardship, Mission Study, and Prayer. The three seasons of special prayer: the Lottie Moon Christmas Offering for Foreign Missions, the Week of Prayer for Home Missions in March, and the Week of Prayer for State Missions in October, have been seasons of uplift and inspiration to giving for our women.

The full statistical report of the work in our Association will appear in the minutes. From available information in hand at the present time, it appears that we have 7 Societies with a total membership of 192. There are 5 Auxiliaries with a total membership of 125. There are 16 of our churches with no W. M. U. work. We know of 3 Mission Study classes and 23 awards.

Every phase of the organized work of Florida Baptists is supported by our women in their organizations.

We feel that the hope of our work and the mission work of our churches, to a great degree, lies in our efforts to teach and train our young people in their Y. W. A., G. A., R. A., and Sunbeam organizations.

Mindful of our material resources and seeing that we are blessed with such a wealth of bright and intelligent young people and ever remembering, "the fields already white unto harvest," we have been led to believe and do here offer for your consideration:

That we should have a fuller cooperation from the pastors of our churches and the Superintendents of our Sunday Schools,

That the women of our churches should be taught that they are a part of our Union, even where no organization is maintained.

That there is a critical and challenging need for us to promote the cause of missions in our churches, and through the Women's Missionary Societies and Auxiliaries of our churches, this coming year, as never before, in order that lost ground may be regained, and in order that, in this day of the world's crying need, a great forward march by the army of our King may begin.

BROTHERHOOD REPORT FOR BEULAH BAPTIST ASSOCIATION YEAR ENDING SEPT. 30, 1940

Florida Baptists are showing, by their growing interest, the vital importance of the enlistment of its man power in the life and work of the church, and the Brotherhood presents the most practical way this can be done.

The State Brotherhood is going forward in a most gratifying way, which was shown by the convention in Lakeland, where more than one thousand men met. This work was represented in twenty-seven of the thirty-six Associations, reaching two hundred and five churches in the state, making a tremendous appeal in all phases of the work.

The State had twenty-six men representing eleven Associations at Ridgecrest in August.

The Brotherhood realizes that vast importance and the work of promoting the Hundred Thousand Club. The Ministers Retirement Plan and your Baptist State paper to be included in each church yearly program.

Remember, that October is State Mission month, and we are depending on our men to cooperate to the fullest extent in meeting our goal of twelve dollars and a half (\$12.50), which is needed to care for the work, that we may go to the convention in January out of debt.

October 20th is Southwide Laymen's Day. Every pastor should help make this a great day in every church.

The Brotherhood should use the quarterly for the basis of the program.

January 14, 1941, is State Brotherhood Convention Day, Meeting with the First Church in Gainesville. Let's all be there.

We recommend that our pastors present the aims and objectives to all their churches; that every church have a Brotherhood, and our Association a well functioning Associational Brotherhood; that every man in our church support the work as he has been blessed. Monthly reports should be made to the church and a copy sent to the Associational Secretary that we may make a report to his Secretary.

FLORIDA BAPTIST CHILDREN'S HOME

T. M. JOHNS, Superintendent

We are admonished to be "doers of the Word and not hearers only." Therefore, the Children's Home represents the gospel as it is preached and the gospel as Christians should live it, for it is by the gifts of those who have heard the Word and are doing it that our Home is able to give shelter to the shelterless, food to the starving, and a home to the homeless.

Our Childrens home does not look to us or anyone else with the eyes of charity; all it asks is help for our children. And just as a mother has the right to call upon her husband to help with the children of their family, so our Home has the right to ask us for help. And this right is not exercised until the children under the leadership of their supervisors have done their best toward supporting themselves. They have a farm, a dairy, a print shop, and other things which lessen expenses of taking tare of the 159 children in the Home. Every child is taught to work and to produce what he can for himself and the others in the Home. It has been estimated that one-fourth of the cost of operating the Home is produced by the children themselves. Therefore, we can easily see that what we give to the support of the Home is not like giving for the support of shiftless or lazy persons; it is instead an opportunity for investing our funds in children whose return to our churches and to society will be highly worth the expense.

Then, too, our Home deserves our help for the mission work it does. The case worker travels thousands of miles every year visiting children, helping their families with their problems, supervising children who have been placed in jobs, and in other ways making a contribution as a missionary of Florida Baptists to the dependent of the State.

Everything in christian work is worthwhile and no element or part of it should be minimized, but the work with our dependent children deserves a high place in our church life. Nothing can be more worthwhile than rearing and training children under a christian influence. No amount of the spoken word could convince people of our sincerity if we allow our children to go uncared for. It is our recommendation, therefore, that every church in this Association give regularly and systematically to the support of our Children's Home in order that we might care for more of our children. In this way our churches will be "doers of the Word."

REPORT OF THE RELIEF AND ANNUITY BOARD

God calls His preachers to preach and determines their success. We have Ministerial education to prepare the preachers for this work, and

to provide a living for them while they work, and Ministerial Relief and Annuity to sustain them when their work is finished.

Relief is charity; Annuity is a business method through which aged Ministers may be retired on a salary.

Insurance cares for a man's family after he is dead, Annuity cares for the man's family after his retirement and death.

This plan calls for the preacher to send to the State Mission Board 3 percent of his salary, the churches to send 3 percent, and the State Board of Missions adds 2 percent. Then the 8 percent is sent to the relief and Annuity Board in Dallas, Texas.

The preacher may retire at 65 years of age and begin to draw fifty percent of this average salary for the past 25 years.

Most of the outstanding churches, not only in Florida, but in the territory of the Southern Baptist Convention, have seen the great need of this plan for the benefit of the aged preachers, and have acted upon it.
